General		Residents don't have access to private golf course and plays no part as parkland or public recreation. Should not be include in the calculation of open space (2).
General		Useful website: Victorian Planning Authority – Metropolitan Open Space Network. Includes gap analysis of 400m walkability to open space from all households across Melbourne.
Glossary		A lack of reference to regional or metropolitan open space and its role in the report.

Glossary		Play can happen in any setting without equipment and should be playground or playspace.
