## *The Re-Development of 31 Bengal Crescent*

The demolition of the house at 31 Bengal Crescent will provide the first test of the creek abuttal provision of C125. The City of Monash has been contacted for an assurance that the special provisions which apply to this block have been adhered to. To date we have not received a response that gives us confidence that the provision of a 7 metre setback, as required by C125, has been taken into consideration when the building permit was prepared. This uncertainty exists because the building plans are approved by a private building surveyor rather than by Council. In theory all special

provisions are available to the private surveyor and whilst we have no reason to suspect they were overlooked, we look forward to the outcome and will continue to be vigilant for new work on properties adjoining the reserve.

## *Fire Safety*

It seems likely that we will be facing a hot, dry summer. With these conditions comes a fear that Damper Creek Reserve could become a fire hazard. Officially, the MFB does not rate Damper Creek Reserve as a high risk as there is not a sufficient area for a significant fire to develop. However, the City of Monash manages vegetation within the reserve to minimise fire risk. Where accessible, a fire break is maintained at the rear of all properties adjoining the reserve.

Within your own property it is wise to minimise build-up of flammable material and to clear leaves from gutters. The following link will guide you to the official City of Monash recommendations on preparing your property.

## *Monash Open Space Strategy and the Monash Urban Landscape and Canopy Vegetation Strategy*

We are very pleased to see that the Monash Open Space Strategy and the Monash Urban Landscape and Canopy Vegetation Strategy were passed at the October Council meeting. The approval of these strategies is the culmination of much hard work by the staff and Councillors of the City of Monash. The expressions of support from organisations such as the Friends of Damper Creek and their individual members over an extended period of time have been critical to this result. These strategies will provide a framework which will improve the liveability of our city for present and future generations.

### Guest Speakers

At our October meeting we were entertained and informed by two knowledgeable and inspiring speakers, Ben Crisfield-Smith and Scott Tunbridge, speaking on the topic of landscaping with indigenous plants. Garden design principles based on the use of small plants in a lightly forested setting, making use of local wildflowers and grasses were demonstrated. One of our members has already engaged Ben as a consultant on garden design and we look forward to seeing that garden develop over the coming years.

The committee is preparing a programme of guest speakers for 2019 and beyond. Suggestions or offers to recruit guest speakers would be welcome.

### Protecting the Yarra River

Members of FODCR have been active in assisting with the development of the Yarra River Protection Act. As a result we, as an organisation, have a close association with the Yarra Riverkeeper Association. We now have a fine publication by the Association titled "Protecting the Yarra Corridor Through Better Planning". This is a comprehensive document, well worth studying.
