## **Sunday 30 August 2015 – Community planting day**

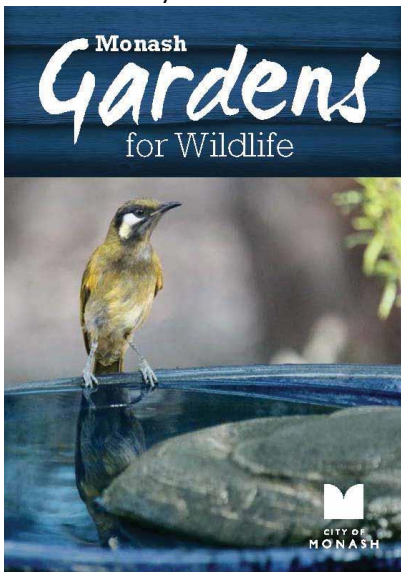

## **Response to MCC Amendment C125: Proposed new residential zones.**

## **Monash Gardens for Wildlife**

The Monash City Council Sustainability Team has recently produced a new publication '*Gardens for Wildlife*'. The booklet explains the importance of the natural environment and biodiversity, details flora and fauna of the Monash region, and provides planting advice for indigenous vegetation.



The aim of this resource is to encourage residents to create indigenous gardens on their properties in an effort to increase biodiversity in Monash. Such gardens would provide greater habitat and 'stepping storeys' for wildlife through this highly urbanized landscape.

Along with this booklet, Monash Council is planning to develop a *Gardens for Wildlife* program. Such a program may include household visits to help residents determine what weeds exist on their property, what indigenous species could replace them and advice on starting and/or further developing their own indigenous garden.

Household visits will be run by a volunteer site assessor who will be trained in how to perform such a visit. Time commitment for volunteers is not likely to be more than approx. one hour for each visit, and they would only have to perform a visit if they are able to at that particular time and date. ## **Bird of the Month – Tawny Frogmouth**

### **What does the Tawny Frogmouth look like?**

The general plumage of the *Tawny Frogmouth* is silver-grey, slightly paler below, streaked and mottled with black and rufous. A second plumage phase also occurs, with birds being russet-red. The eye is yellow in both forms, and the wide, heavy bill is olive-grey to blackish. South-eastern birds are larger than birds from the north. *Tawny Frogmouths* are nocturnal birds. During the day, they perch on tree branches, often low down, most cleverly camouflaged as if they were part of the tree.

### **What does the Tawny Frogmouth do? - Feeding:**

The bulk of the *Tawny Frogmouth's* diet is made up of nocturnal insects, worms, slugs and snails. Small mammals, reptiles, frogs and birds are also eaten. Most food is obtained by pouncing to the ground from a tree or another elevated perch. Some prey items, such as moths, are caught in flight.

**Breeding -** *Tawny Frogmouths* have a regular breeding season, but birds in more arid areas may breed in response to heavy rains. Both male and female incubate the eggs. The male sits during the day, but both the male and female share sitting at night. The nest is a loose platform of sticks, which is usually placed on a horizontal forked tree branch. Normally only one brood is raised in a season, but birds from the south may have two.

**Did you know ?** - The leading edges of the first primary wing edges of the *Tawny Frogmouth* are fringed to make for silent flight.

Listen out for the *Tawny Frogmouth's* call and sightings already enjoyed in Damper Creek Reserve – near the end of Sunhill Road, or in the trees at end of Richard Road or trees just near the main pond on the upper hillside in the backyards of the Park Road houses.

A soft deep continuous ooo-ooo-ooo sound – at sundown – it is a beautiful experience to hear this call.

## **Proposed subdivision of 41–43 Alvie Road & removal of significant trees: possible conflict with newly proposed Residential Zoning “Creek Environs”**

Recently, many concerned residents' in this neighborhood responded to MCCouncil objecting to a proposal to subdivide 41 – 43 Alvie Road into three separate titles and remove 18 of 25 significant (VPO protected) trees (in an area proposed to be covered under “Creek Environs”, under Amendment C125). As a result of the considerable number of objections, TPA/44432 will now go into further consultation and re-advertisement. Revised proposed planning application signage will be placed on that property (or the MCCouncil website) which will indicate a deadline for a further opportunity to provide comment to MCCouncil.

## **Guest Speaker – August – Mr Andrew Kelly, Yarra Riverkeeper**

As Damper Creek is part of the Yarra River catchment, FoDC were most pleased to welcome Mr Andrew Kelly, Yarra Riverkeeper, as guest speaker at our August meeting. It was a very interesting and thought provoking presentation including the following update from Mr Kelly on the YRK's future goals:

*“The Victorian State Government has followed up on their election commitment for the Yarra River Protection Act and a Yarra Trust, and allotted \$1million in the May budget to this initiative. Planning reports have repeatedly identified fragmented responsibilities and*

*inconsistent planning as issues along the River. A Yarra Trust would ensure that there is co-ordinated management on the River and the Trust would be able to carry initiatives for protecting and improving the Yarra through from one government to the next. The Yarra Riverkeeper Association advocates for an Act that covers both planning and water issues, including storm water management across the catchment."*

## **AUGUST AGM – new Committee**

The outgoing President Helen Clements presented an annual report to the AGM, firstly thanking each of the Committee members and all the Friends for their wonderful support in achieving another successful year as FoDC enters its 22nd year of being an Incorporated Friends' group.

Helen's report highlighted significant events in that FoDC celebrated its 21<sup>st</sup> birthday at its November 2014 Christmas bbq. In 2015, FoDC held monthly meetings and monthly working bees, including four extra planting working bees and a vibrant and interesting Guest Speaker program.

FoDC were awarded a further Melbourne Water project grant for 2016 including a grant for the purchase of tube stock for the riparian strip, together with an administrative grant to fund activities and admin expenses throughout the year.

The Friends also actively liaised with MCCouncil together with the Friends of Scotchmans Creek and Valley Reserve on the possibility of introducing greater protections for *Creek Abuttal and Creek Environs* through the ongoing process of *Amendment C125*.

The MCCouncil and its Heritage Team and the Bushcrew members were thanked for their wonderful support and organisation in making FoDC's working bees and extra working bees come to fruition.

Under Romy Orfanelli's guidance, the new Committee for 2015 – 2016 was elected as follows: John Clements (President), Helen Clements (Secretary), Ian Nicholls (Treasurer), Kevin Ryland (Vice President), with general committee members being Joan Wolf (subscription database), John Wolf (Noticeboards), Doug Scott (Editor), and Robert Yates (catering). Frank Carder was also nominated to continue as water watch co-ordinator. The new Committee was warmly welcomed by the new President, John Clements.
